Our members are Texas' first line of defense

The Texas State Troopers Association (TSTA) is the largest organization in Texas consisting solely of active and retired state-commissioned law enforcement officers of the Texas Department of Public Safety (DPS). Its 1,000-plus members encompass commissioned officers of every division of the DPS, from troopers to commanding officers.

Established in 1984, TSTA is a non-profit, tax-exempt 501(c)(5) organization that receives no state funding. It is not part of the Texas Department of Public Safety or an entity of state government, and relies solely on the contributions of citizens. The Texas State Troopers Association strives to improve the standards of employment, training, and education for Texas DPS officers through legislative advocacy. In doing so, TSTA plays a crucial role in improving the effectiveness of law enforcement not just for DPS officers, but in law enforcement statewide.

anywhere in the state of Texas. Increasingly, they use highly sophisticated technology to conduct their duties, which include:

- Enforcing state traffic laws by patrolling the highways;
- Enforcing all traffic and criminal laws, investigating traffic accidents, criminal interdiction, fugitive arrests, and stolen vehicle recovery;
- Responding to and investigating traffic accidents in rural areas;
- Providing executive security for the governor, state officials, as well as security and safety at the State Capitol Complex;
- Enforcing all commercial vehicle laws, both state and federal, to ensure the safety of commercial vehicle traffic and drivers;
- Conducting all levels of criminal investigations, both misdemeanor and felony such as narcotics smuggling, sex offenses, human trafficking, street and prison gang activity, organized crime, public corruption, and homicide - and other common criminal investigations, working in conjunction with local, state, and federal agencies;
- Providing statewide criminal law enforcement, especially in rural areas where local police are limited;
- Participating in selective specialized units, such as DPS regional S.W.A.T. teams, marine patrol, and dive recovery, as well as operations involving fixed-wing aircraft, helicopters, and evolving technology such as drones;
- Conducting Special Emphasis Operations in known areas of high criminal activity;
- Providing rescue and recovery operations during major catastrophes and disasters; and
- Educating citizens on traffic safety practices, such as child safety seats and proper vehicle maintenance.

Current Programs and Benefits

Death and Disaster Assistance

- Direct financial assistance to members and their families affected by a natural disaster, critical incident in the line of duty, a family crisis, or extraordinary need; and
- Free accidental death and dismemberment benefits.

Legal Representation

Texas State Troopers Association members receive free legal representation:

- In situations arising out of the good-faith performance of their duties; and
- For unreasonable administrative acts against them while employed by the Texas DPS.

Tragedy is a daily possibility for a commissioned DPS officer due to the dangers inherent in their jobs. To protect their families and preserve their own peace of mind, the Texas State Troopers Association offers free legal assistance in preparing or updating their last will and testament.

Legislative Representation

The Texas State Troopers Association engages a legislative consultant who proactively works with Texas legislators and their staffs to promote TSTA members' interests. Through these activities, we directly impact the employment standards, training, and education of commissioned DPS officers by:

- Monitoring legislation that may impact commissioned DPS officers and their families;
- Analyzing proposed legislation and suggesting changes, where appropriate;
- Presenting written and oral testimony in committee hearings; and
- Reporting to the Texas State Troopers Association and its members on legislative outcomes.

Preparing for the Dangers of 21st Century Law Enforcement
